We will be walking through the book of Ruth beginning the weekend of September 23 and 24th. Join us and bring your family and friends to see what loyalty looks like and to understand one of the most important verses (v. 16) found in the Book of Ruth, "Do not press me to leave you, to turn back from following you! Where you go, I will go; where you lodge, I will lodge; your people shall be my people and your God my God."

May God continue to bless you as the weather turns and may you continue to share the love of Christ with all you meet!

CHURCH COUNCIL REPORT SEPTEMBER 2023

The monthly meeting of the Church Council was held September 20, 2023. This report is submitted to communicate to our congregation the work of the Council. By way of background, the Council serves as the Administrative Board, Trustees, Finance and Staff Parish Relations Committees in a governance and oversight role over all ministries. Church Council meetings are open meetings except when the Council deals with Staff Parish Relations matters.

The following are the major items from the Council's agenda discussed at the September meeting:

- For our spiritual development we discussed chapter ten in the book "Autopsy of a Deceased Church 12 Ways to Keep Yours Alive" by Thom Rainer. We will identify those ways to stay healthy and alive. The prayer commitment for Chapter Ten, The Church Had No Clear Purpose, was the following: *God, reignite the hearts of our church members, including me, to have a passion for the gospel. Teach our church to share the gospel with others. Teach us to live as men and women who are true bearers of the good news of Jesus Christ. Remind us of our purpose. Convict us of our purpose. Empower us to live our purpose.* We encourage the congregation to also consider this prayer and the challenge it poses for us.
- Approved August Council meeting minutes
- Reviewed August Council newsletter report.
- As we do every meeting, we reviewed the monthly financial report and balance sheet. After eight months
 of the year we are running a deficit of \$10,968.12. The deficit would be larger were it not for the fact we
 take income from our investment account. We will continue to monitor this as it may impact ministries.
 We encourage the congregation to consider our response to the membership vow to support the ministries
 of the congregation through our prayers, presence, witness, service and gifts.
- Heard from the maintenance team that the roof top unit providing air conditioning to the cave classroom needs replaced at a cost of \$9,645.00. We will not act on this until spring since air conditioning season is essentially over for 2023. We will have the Fellowship Hall floor refinished in December. The canopy doors have malfunctioned and need a new magnet which is on order. Until it is received for installation we need to secure the doors with the bar.
- Learned the WiFi in the sanctuary has been upgraded. We approved upgrading the WiFi in the balance of the building with the \$1,400.00 cost to be donated by Boy Scout Troop 14.
- The Lay Leadership Team has met and is working on persons to serve on Church Council to replace those persons leaving at the end of 2023.
- The Congregational Care Team continues to explore fellowship opportunities for the congregation. The block party that was planned for our parking lot in September of 2023 has been postponed until next year.
- The Finance Team met at Woodlands Bank to review our investment portfolio with our investment advisors
 We have begun the budget preparation process with a draft budget. Council will review a revised draft in
 October with approval in November.
- We discussed several staff issues. We will advertise for a new choir director. We approved a change in job title for the Church Administrator position. It will now be Office Assistant and hours will be reduced.
- We are planning a congregational meeting, hopefully in October, to discuss disaffiliation and other issues impacting the United Methodist Church. Our hope is to have representatives from the conference office attend to present and answer questions.
- Our annual church conference will be Monday, November 13, 6:30pm at Saint John's Newberry. This will be a cluster meeting with the other churches in the Williamsport District.
- Moving forward, we will continue the practice at the beginning of our meeting to provide time for any
 member of the congregation to address Council with any comments or concerns. Time will be limited to
 five minutes. This will permit input without the need to stay for our entire meeting.
